#### REQUIREMENT

A person in charge of a recreational powerboat with a motor in excess of 6 hp requires a RST.

#### COURSE REQUIREMENTS

- Your boat
- Safety equipment for the waters in which you will be operating (Inshore)
- Lunch (Morning Tea/Coffee is provided)
- Hat, sunscreen, suitable clothing
- Suitable lines for securing your boat to the jetty
- Safety equipment for inshore, unprotected waters.

#### TRAINING COURSE TIMINGS

The course commences at 8.15 am and covers all aspects of the requirements plus a wider range of subjects and information designed to provide a sound understanding of recreational boating. During the course you will complete both the theory and practical assessment.

#### TRAINING COURSE DATES

#### TRAINING COURSE LOCATION

Conducted at the Bunbury Sea Rescue base off Casuarina Drive Bunbury near the pilot jetty (follow the signs) from the Port Authority weighbridge on the land back wharf.

## **ASSESSORS AND INSTRUCTORS**

Assessment will only be carried out by qualified & experienced trainers and RST Assessors approved by the Dept of Transport and operating through a Registered Training Organisation in this case Yachting WA.

## **RST APPLICATION**

This is the form that is provided with others to the DPI and results in the issue of your RST.

To complete it will require:

- Proof of identity - a current motor driver's licence with photo will suffice for POI and the Eyesight test.
- A passport and RST medical certificate is also acceptable
- Alternatives are approved for persons not holding a passport or a MDL.

## **INDEMNITY**

You are required by the DPI to provide an indemnity when using your own boat. (Form attached)

## **PAYMENT**

You will be required to pay the course fee of \$200. Cash, postal order or cheque made out to BUNBURY SEA RESCUE A receipt will be issued.

You will only be confirmed on a course once we receive your completed application form and a deposit of \$50 at least 7 days prior to the course.

## **RST WORKBOOK**

This is available free from most boat shops, from the Dept of Transport Office in Symmons St Bunbury or from BSR on Sunday between 9am and 12 noon.

You are expected to have familiarised yourself with the contents of the RST Workbook prior to the course by reading it thoroughly.
